

## DELEGATE APPLICATION

Between **28 and 30 November 2025**, the 12th edition of the **MUNLawS** Model United Nations Conference will be held at the Faculty of Law, University of Ljubljana. The organizing team invites all interested individuals and members of the delegations to participate in the conference as **delegates** and **observers**.

MUNLawS is a leading university-level Model United Nations conference in Slovenia, organized annually by the Department of International Law at the Faculty of Law, University of Ljubljana. It is aimed at high school and university students as well as young professionals. So far, 11 conferences have been held, bringing together over 1,500 delegates from more than 40 countries.

## II. MANDATORY REQUIREMENTS

All applicants must cumulatively meet the **following mandatory requirements**:

- a. ability to travel to Slovenia for the duration of the conference;
- b. not be younger than 15 or older than 27 years of age at the time of the conference. Younger candidates will be admitted only as members of a delegation and must be accompanied by a Head Delegate, Delegate, or Observer who is at least 18 years old.

The **university** applicants must also meet **one of the following criteria**:

- a. being a university student in the academic year 2025/26;
- b. the applicant's student status is temporarily paused in the academic year 2025/26, but not for more than 1 academic year.

The **high-school** applicants must meet **the following criteria** of being at least a second-grade high-school student in the school year 2025/26.

All mandatory requirements and advantage elements are to be proven with **authentic documentation**.

## IV. APPLICATION FEES AND PAYMENT INSTRUCTIONS

Early Bird applications fees, including value-added tax, are as follows:

- a. **109.90 €** per **individual** delegate and individual observer;
- b. **104.90 €** per delegate and observer of a **small group** of 2 – 9 delegates;
- c. **99.91 €** per delegate and observer of a **large group** of more than 10 delegates;
- d. **59.90 €** per delegate who is a **student** or an incoming Erasmus+ **exchange student** at the **University of Ljubljana**.

The application fee covers conference materials, complimentary coffee breaks during all three days of the conference, as well as lunch on Saturday and Sunday, and a certificate of participation.

Within five working days of submitting the application, candidates must transfer the exact amount of the application fee to the bank account provided below. If the fee is not transferred within this period, the submitted application will be considered null and void. Only after the payment is received, will the candidate be assigned to the committee post.

## V. THE ALLOCATION PROCEDURE

Aiming to ensure a fair and merit-based allocation procedure, candidates shall be assigned to their posts according to the **following criteria**:

- a. the expressed preferences of the committees;
- b. the candidates' stage and field of study;
- c. previous MUN experience, including any awards received;
- d. the applications of other members of the same delegation;
- e. the time of the application submission.

**High-school applicants** may, upon their expressed interest and at the discretion of the Organising team, be assigned to university-level committees, with the exception of the Security Council (UN), the European Court of Human Rights, and the Court of Conciliation and Arbitration within the Organization for Security and Cooperation in Europe.

The Organising team reserves the right to allocate candidates based on considerations beyond the above-mentioned criteria. It also reserves the right to refuse an application and refund the applicant. The final decision of the Secretariat shall not be appealable.
